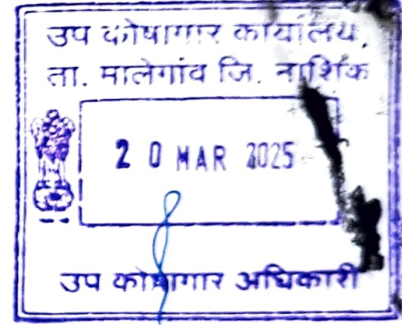

## MEMORANDUM OF UNDERSTANDING

We the "Malegaon Municipal Corporation, Malegaon" Nashik & Department of Civil Engineering from KCT's Late G. N. Sapkal College of Engineering, Kalyani Hills, Anjaneri Trimbak Road, Nashik, Maharashtra hereby signing the MoU with the following terms and conditions.

### 1. PURPOSE:

This Memorandum of Understanding (MoU) establishes a partnership between the College and the Corporation to conduct third-party audits. The objective is to assess and improve compliance, quality standards, and operational efficiency as per the agreed terms.

### 2. SCOPE OF WORK:

The College shall provide the following services to the Corporation:

- Provide qualified auditors/faculty/students for the technical audit.
- Conduct audits in an unbiased and professional manner.
- Perform Non-Destructive Testing (NDT) as required.

- Prepare third-party technical reports based on findings.
- Submit audit reports with findings and recommendations.
- Maintain confidentiality of all corporate data and information.

**The Corporation shall:**

- Provide access to necessary data, facilities, and personnel.
- Cooperate with the auditors during the audit process.
- Implement recommendations for improvement where feasible.
- Ensure compliance with applicable regulations and policies.
- Bear the costs associated with NDT, audit, and third-party technical reporting as per agreed rates

**3. CONFIDENTIALITY:**

Both parties agree to maintain confidentiality of all proprietary information and audit findings. Any disclosure of information shall require prior written consent from the respective party.

**4. FINANCIAL ARRANGEMENTS:**

- The cost of testing and auditing shall be borne by the Corporation as per agreed rates.
- The Corporation may provide financial assistance or grants for research and training initiatives.
- Rate of Technical audit will be 1% on estimate plus GST.
- Rate for Structural Audit will be Rs. 1 per sq. feet. plus GST.

**5. DURATION & TERMINATION:**


- This MoU shall remain in effect for a period of 2 years (i.e. 2025-26, 2026-27) from the date of signing.
- Either party may terminate this MoU by providing 30 days' written notice.

**6. DISPUTE RESOLUTION:**

Any disputes arising under this MOU shall be resolved amicably through mutual discussion. If unresolved, the dispute shall be referred to arbitration in accordance with the governing laws.

**7. GENERAL TERMS:**

Any amendments to this MoU shall be made in writing and signed by both parties.
